

# High Speed Infrared Emitting Diode in T-1¾ Package

### **Description**

TSHF5410 is a high speed infrared emitting diode in GaAlAs double hetero (DH) technology, molded in a clear, untinted plastic package.

TSHF5410 combines high speed with high radiant power at wavelength of 890 nm.




Figure 1. Power Dissipation Limit vs. Ambient Temperature




Figure 2. Forward Current Limit vs. Ambient Temperature




Figure 3. Pulse Forward Current vs. Pulse Duration




Figure 6. Radiant Power vs. Forward Current




Figure 4. Forward Current vs. Forward Voltage




Figure 7. Relative Radiant Power vs. Wavelength




Figure 5. Radiant Intensity vs. Forward Current






Figure 8. Relative Radiant Intensity vs. Angular Displacement
